- I have reviewed the dress code and understand what is required at all times on the golf course as well as the practice tee and consists of; shirt (no tank tops) with Bermuda-style shorts or slacks and shoes are required.
- I acknowledge that the management of Riverside & Blackhawk Golf Courses may terminate this card at any time due to improper conduct by the cardholder. In the event of a season ending medical condition, a letter from the cardholder's doctor is required to be eligible for any refund. Refunds will be given to the cardholder upon termination of the card and pro rated starting from January 1, 2020.
- I understand that the benefits from this card expire on December 31, 2020.
- I acknowledge that this card does not establish any property right or permanent entitlement for special benefits at Riverside & Blackhawk Golf Courses.
